1. The EOI is to be submitted along with Sales Tax/Income Tax certificates together with Demand Draft/Deposit at call super scribing there on "EOI for purchase of 30(thirty) nos. Confiscated Vehicles". The Tender shall be received in the Tender Box kept at (i) Sadar Forest Range Office Melarmath, Agartala and (ii) in the office of the SDFO Sadar, Agartala within the given date & time.
2. The vehicles will be disposed of on "AS IS WHERE IS" basis.
3. Tender/EOI as available in the Tender Boxes will be opened at 3.00 pm on ~~25-01-~~ 17/01/2017 in the office chamber of the SDFO, *if possible,* Sadar, Agartala when the Tenderers may remain present.
4. EOI/Tender shall not be accepted by post.
5. EOI should accompany upto date Income Tax/Professional Tax/Sales Tax Clearance certificates together with required earnest money which shall only be considered.
6. The SDFO, Sadar reserves every right to except or reject of any or all EOI in part or full at any stage without assigning any reason.
7. Sales Tax/Vats or any other taxes if any applicable/liable as per rules in force on account of thus disposal/sale will be charged extra at actual, which the Tenderer shall be liable to pay to the concerned Sales Tax Authority in addition to his/their Tendered/Quoted amount. The Tenderer shall have to furnish a certificate from the Sales Tax Authority to be effect of his/their payment of Sale Tax in respect of the deal to the SDFO Sadar and in absence of it, delivery order shall not be issued even after payment of the Tendered amount.
8. On acceptance of the Tenderer / EOI by the Forest Department, the Tenderer will require to deposit the valuation in one instalment(minus the EMD) within 15(fifteen) days time. The mode of payment is Bank Draft of any scheduled Nationalized Bank payable at Agartala. The delivery order is subject to encashment of the Demand Draft.
9. After the issue of delivery order the Tenderer shall have to remove the vehicle within 15(fifteen) days time.
10. Legal Dispute if any shall be restricted to the legal jurisdiction at Agartala only.
11. The disposal of the Confiscated vehicle is "AS IS WHERE IS" basis and the Forest Department is not liable to bring the vehicle on road condition and put use of the vehicle under public transport system or otherwise on getting licence/Renewal/Driving etc. purposes and for obtaining clearance from the Transport Department in this regard.
