TENDER NOTICE

Sealed tenders on plain paper are hereby invited by the undersigned on behalf of the Tripura Forest Department, for disposal of **59.520 Cum** round timber of Teak and other ordinary timbers kept at Kailashahar Range under Kailashahar Forest Sub-Division, Unakoti District, Tripura. An Abstract of timber lots is shown in Annexure – A. The sealed tenders should be dropped in the Tender Box in the office of the Sub-Divisional Forest Officer, Kailashahar Forest Sub-Division on or before 03:00 PM of the 19-01-2017.

TERMS AND CONDITIONS

1. The tender may be sent by Registered post /Speed post or by hand or may be dropped in person in the tender box to be kept in the office of the undersigned in sealed cover up to the time and date as quoted above.
2. A copy of the complete list of round timbers and its measurements can be obtained from the office of the undersigned or Range Office, Kailashahar on any working day during office hours except on holidays. The same is also available on the portal of the Forest Department, Government of Tripura (<http://www.forest.tripura.gov.in>) as well as in the State Portal of Government of Tripura
3. The rate must be quoted both in figures and words on per cum basis for each lot and which will be exclusive of the leviable "Value Added Tax, Income Tax, Surcharges on Income tax and carrying cost and conversion cost", etc. as per rule.
4. For each lot "earnest money" for an amount of Rs. 7,000/- (Rupees seven thousand) only in the form of Deposit-at-Call from any Nationalized Bank of India is to be deposited in favour of the Sub-Divisional Forest Officer, Kailashahar Forest Sub-division, Unakoti, Tripura.
5. The tenderer will also require submitting a copy of the PAN Card along with the tender documents.
6. Without such earnest money, no tender will be considered as valid and therefore, will be rejected out rightly. Earnest money of all tenders except the first, second & third highest tenders will be released within fifteen days from the date of opening of the tenders.



7. The lots of timber will be sold & delivered on 'as is where is' basis and thereafter no complaint regarding quantity, quality, species and measurement etc. against any lot will be entertained. The earnest money will be liable for forfeiture in case of any violation of the terms and the conditions laid down in this Tender Notice. The tenderer must satisfy himself/herself about quantity, quality, species and measurement etc. by field verification at depot of Kailashahar Range before submitting the tender. No plea citing misunderstanding or ignorance of conditions put forth subsequent to any confirmation of sale shall be accepted.

8. Conditional offers will be deemed to be invalid and will be rejected forthwith.

9. The successful tenderer shall have to furnish security money to the extent of **25% of the tendered value so accepted within 7 (seven) days of issuance of acceptance letter** and this security money will be adjusted against the costs of timber lots allowed to the tenderer. The security money is liable of forfeiture for violation of terms and conditions laid down in the Tender Notice or in the event of refusal to pay the balance value for any reason whatsoever.

10. The Successful tenderer shall have to deposit the entire value of timbers including leviable Value Added Tax, Income Tax, Surcharges on Income Tax, Carrying Cost, etc. as per rule though "Treasury Challan/GP under the appropriate Head of Accounts within **15 (fifteen) days of the acceptance of the tender** by the competent authority. Only thereafter the sale marking and transit permit for the logs will be allowed.


11. The expenditure incurred as carrying Cost and conversion cost will be added to the sale price.

12. No dragging, lifting, storage, transportation and other facilities will be provided to the successful tenderer by the Forest Department as such works are to be arranged by the tenderer himself.

13. The timbers will have to be lifted by the successful bidder within **10 (ten) days of the date of depositing of Government dues royalty taxes etc.** in case of default the department shall not be liable to any loss /damage to the produce beyond this periods of 10 (ten) days after depositing all Govt. dues taxes etc.

14. It is not mandatory to possess FTL (Forest Trade Licence) for interested parties to participate in this tender. The successful tendered may obtain required Licence later on if deemed necessary.


15. The undersigned reserves the right to accept or reject any tender including the highest one without assigning any reason.


