Notification

In exercise of the powers conferred by section 29 of the Indian Forest Act, 1927 (Act XVI of 1927), the Governor of Tripura is pleased to decide to constitute 1.50 acre (0.607 ha) and 2.25 acre (0.91 ha) of non-forest land mutated in favour of Forest Department against the forest land diverted for non-forestry purposes respectively for setting up of "Dasharath Dev Smriti Soudha" and "Ampura Growth Centre" under District Forest Officer, Khowai District as 'Protected Forests' and that are not under reclamation orders of the Revenue Department situated within the State of Tripura (as per particular described in the schedule below) with immediate effect and under Chapter-IV of the said Act shall now apply to these forests.


