The office of the DISTRICT FOREST OFFICER, Sepahijala, Tripura invites on behalf of the "Governor of Tripura" from the bonafide, experienced and resourceful dealers / suppliers of Indian Nationality for supply of animal feed materials for the animals, reptiles and birds housed at Sepahijala Zoological Park, Sepahijala for the period of 365 days from the date of Award of Contract.

- Eligible bidders shall participate in bidding only in online through website <https://tripuratenders.gov.in> The bidders are allowed to bid 24x7 until the time of Bid closing. The website will not allow any Bidder to attempt bidding, after the schedule date and time. **Submission of Bids physically is not permitted.**





2. The intending bidder must read the **terms and conditions of Nle-T carefully**. He / She should only submit his / her bid if, he / she considers himself / herself eligible and he / she is in possession of all the documents required.
3. Information and instructions for bidders posted on website shall form part of bid document.
4. The bid / tender document and the set of terms and conditions of the tender to be complied with other necessary documents can be seen and downloaded from the website [www.tripuratenders.gov.in](http://www.tripuratenders.gov.in) free of cost.
5. Earnest Money Deposit (EMD) is to be paid electronically over the online payment facility provided in the portal, any time after Bid Submission Start Date & before Bid Submission End Date, using the supported payment Mode (Net Banking).
6. Bid Fee is to be paid electronically over the online payment facility provided in the portal, any time after Bid Submission Start Date & before Bid Submission End Date, using the supported payment Mode (Net Banking) and it is non-refundable and to be deposited to the Government account automatically as revenue.
7. To participate in e-Tender, the bidder shall have at least **valid Class 3 Digital Signature Certificate (DSC)**.
8. The bidder / tenderer can upload documents in the form of PDF format (in 100 dpi scan resolution).
9. On opening date, the bidder can login and see the bid opening process. After opening of bids he / she will receive the competitor bid sheets.
10. Bill of Quantity (BOQ), which is the Rate quoting sheet in Ms-excel shall be downloaded, filled up properly and uploaded in the bid after digital signing. The Bidder shall always open the BOQ sheet with Macros Enabled.
11. Bid(s) shall be opened through online by respective Bid openers on behalf of the District Forest Officer, Sepahijala, Tripura and the same shall be accessible by intending Bidder through website <https://tripuratenders.gov.in>. However, intending bidders may like to be present at the Bid opening.
12. If the Item rate quoted in the pre-defined BOQ by a Tenderer is found to be either abnormally high or low as compared to the existing market rate or it is found that any error is there and not as per tender guidelines at the time of tendering process, such tenders shall be rejected and in that case L2 will be considered for approval.
13. Each Tenderer shall submit only one Tender for one Group. A Tenderer who submits more than one Tender for one Group will cause disqualification of all the Tenders submitted by the Tenderer for that concerned Group.
14. Any Tenderer can participate in Tender for more than one Group.
15. The Tender parties or bidders shall be selected separately for each item quoted within a Group on the basis of the lowest rate quoted for the concerned item within a Group and other valid considerations.
16. The rates quoted for every item should be inclusive of all Taxes, transportation cost upto Food Godown of Sepahijala Zoological Park and all other statutory obligations.



17. Each Tenderer should quote rates of all items for the concerned Group or else it will lead to disqualification of the Tender.
