NOTICE INVITING SHORT QUOTATION

Sealed quotation is hereby invited on behalf of Government of Tripura from the intending bonafied and resourceful vehicle owners for transportation of seedlings to various Gram Panchayet (GP)/ Village Council (VC) for distribution of seedlings for observance of Chief Minister's Swanirbhar Pariwar Yojna (CMSPY) during 2021-22. The number of seedlings to be transported in different RD Blocks.

Sealed quotation will be received in the office of the SDFO, Mandwi from 01.05.2021 to 15.05.2021 upto 04.00 PM & will be opened on the same day i.e on 15.05.2021 at 04.30 PM if possible, otherwise on the next working day at 11.30 AM.

Terms & Conditions:

1. The "Earnest Money" for an amount of **Rs.5,000/- (Rupees five thousand)** only in the form of Deposit at call or **Demand Draft** in favour of the **Sub-Divisional Forest Officer, Mandwi** from any Nationalized Bank shall be submitted along with the sealed quotation Tender without such "Earnest Money" will not be considered and quotation will be rejected. The said earnest money will be covered into security money for successful bidder in case successful bidder applied for. For others the earnest money would refund after finalization of the work order.
2. Sealed quotation must be sent by "Registered Post" OR "Speed Post", OR "By hand", OR "may be submitted in person" in the office of the undersigned in sealed cover within time and date quoted above.
3. The bidder should have valid licence, Registrations, fitness certificate, & other relevant documents of the vehicle.
4. The Bidder should submit photographic identity card along with proof of domicile and other relevant documents of ownership, up to date tax clearance certificates, PTC/ITC, PAN card etc. and submit along with the quotation.
5. The rate must be quoted both in figures and in words for per seedling & per KM including loading & unloading inclusive of all taxes as applicable (GST, income tax, and surcharge on income tax & carrying cost etc and to be submitted as per given format below:

6. The seedlings shall have to be transported from Raktiacherra Central Nursery/ Khamtingbari Nursery/ Hatipara Central Nursery/ Ananda Nagar Nursery and shall be decided by the respective Range Officers.
7. The date, time and place for transportation and distribution shall be fixed by the concern Range Officer.

8. The seedlings if left balance after distribution shall be brought back to the original place where from the seedlings had been transported.
9. The undersigned reserves the right to accept or reject any quotation including the "lowest one" without assigning any reason.
10. The undersigned reserve the right to cancel the quotation without assigning any reason in case of disputes arising out of the quotes.
11. The accepted rate shall be valid for the period of 2021-22 only.
12. The quantity of seedlings to be transported may increase or decrease.
13. The Bidder should submit Challan/ Voucher for payment against the number of seedlings transported and such challan should be authenticated by the concern Range Officer.
14. After satisfactory supply of the item / items, payment will be made by bill basis on availability of fund, no advance payment will be entertained.
