NOTIFICATION

In exercise of the powers conferred by Section 51A of the Indian Forest Act, 1927, as amended by Indian Forest (Tripura Amendment) Act, 1984 read with clause (d) of Section 76, the Governor, Tripura is pleased to further amend the Tripura Forest (Establishment and Regulation of Saw-mills and Other Wood Based Industries) 1985 (herein after referred to as the principal rules) namely-

A. SHORT TITLE, EXTENT AND COMMENCEMENT:


- (1) These rules may be called the **Tripura Forest (Establishment and Regulation of Saw-mills and Other Wood Based Industries) (Seventh Amendment) Rules, 2023.**
- (2) This shall extend to the whole of Tripura.
- (3) This shall come into force on the date of their publication in the Official Gazette.

B. Amendment of Rule 6:

In the Principal Rules, sl no 4(b) of sub-rule(1) of rule 6 shall be substituted with the following:-


