### SHORT TENDER

Scaled tender on a plain paper are hereby invited on behalf of the Governor of Tripura from the bonafide Indian Citizens for supply of following specified Hard drawn *jhungra* for the use in *Roadside plantation 2018-19 under various Ranges of Sadar* Forest sub-Division. The tender maybe dropped between 10:00 AM to 4:00 PM in the box kept in the office of the Sub-Divisional Forest Officer, Sadar on all working days. The sealed tenders should be dropped/ reach to this office up to 2:30 PM of 15-06-2018 positively. The same may be opened on the same day at 4:00 PM if possible or next working day.

### Requisite specification

3mm Iron net(hard drawn steel wire fabric.) 3 nos iron angle (MS Angle) of 19 x 19 x 5 mm and 1.10 M from ground level height of a *jhungra* + 0.40 M underground height of an angle, 3 nos iron flat (M.S flat) 15mm x 4 mm, diameter of the plant guard 0.45m and one name plate of 6" x 4" including colouring with primer and forest colour, applicable Tax, carrying to the plantation site. Average weight of Hard drawn Plant guard should not be less than 8 kg.

### TERMS AND CONDITIONS:

1. Sealed tenders must be sent by "Registered Post" OR "Speed Post" OR "By Hand" OR "Maybe dropped in person" in the tender box to be kept in the office of the undersigned in sealed cover up to the time and date quoted above.
2. The participant should be registered vendor under MGNREGA in West district preferably. He should possess all the relevant documents of a supplier such as necessary tax clearance certificates, TIN, Pan Card etc.
3. The rate must be quoted both in figures and in words which inclusive of GST, income tax and surcharge on income tax and carrying cost as per rule. The rate of a hard drawn *jhungra* must be quoted for particular Range in the tender (Sadar/Mohanpur/ Sadar SF/Subalsingh Range).
4. The earnest Money for an amount of Rs.10000/- (Ten Thousand)only in the form of Deposit-at-Call from any Nationalized Bank of India is to be deposited in favour of the Sub-Divisional Forest Officer, Sadar along with the tender, without which the tender will be considered invalid & out rightly rejected. Earnest money of successful tenders except the first, second and third lowest bidders will be released within fifteen days from the date of opening of tender & on receipt of application from the bidder. The earnest money will be liable for forfeiture for violation of the Terms & Conditions laid in this tender notice.
5. The successful bidder shall have to furnish security money to the extent of Rs.50000/-(Rupees fifty thousand) only within 2 (two) days of issuance of acceptance letter and the full payment will be way of FTO as practiced in MGNREGA.
6. The Security money will be released after completion of works and full payment thereof.
7. The undersigned reserves the right to accept or reject any tender including the "lowest one" without assigning any reason.
