2. The Broom grass will be sold on as is where is basis. Interested bidders may physically verify the stock lying under Nogang Mini CCFC of Panisagar Range under Dharmanagar Forest Sub-Division for satisfaction.
3. The traders/ bidders have to quote rates per KG for dry & old broom grass in the following format



5. The bidders who has quoted highest price will be declared successful to purchase of the dry & old broom grass at the price quoted.

No person other than the successful bidders or his Authorized representative shall be allowed to procure the fuljharu from the concerned Range Forest Department will issue transit pass for fuljharu only to the Authorized representative bidder. The successful bidders shall procure broom grass (Dried & Old) from the Mini CCFC of the concerned Range Panisagar.
7. In case the successful bidder fails to procure the fuljharu at the price quoted after making the complete payment within one week time, the order will automatically stand cancelled from the date of default and next highest bidder will be declared as "Successful Bidders" for the Range without further correspondence.
8. The bidders should have valid license to carry on trade in Forest Produces (FTL)
9. The bidders have to provide information about name, Phone number, Addhaar card of the bidder as well as of their Authorized representative in EOI document itself. Successful bidder
