Call for an amount of Rs. 5000.00 (Rupees five thousand) only placed in favour of the (Sub-Divisional Forest Officer, Kumarghat Forest Sub-Division) has to be enclosed along with the EoI without which no offer will be treated valid for acceptance. In case of successful traders/bidders, the earnest money will be forfeited in case of non compliance of terms and condition of the EoI.
12. The Broom grass will be sold on as is where basis. Interested bidders may physically verify the stock lying under Kumarghat Forest Sub-Division for satisfaction.
13. The traders/ bidders have to quote rates per KG for dry & old broom grass in the following format

14. The bidders who has quoted highest highest price will be declared successful to purchase of the dry & old broom grass at the price quoted.
15. No person other than the successful bidders or his Authorized representative shall be allowed to procure the fuljharu from the concerned Range Forest Department will issue transit pass for fuljharu only to the Authorized representative of the Government. The successful bidders shall procure broom grass (Dried & Old) from the Mini CCFC of the concerned Ranges Pecharthal and Machmara.
16. In case the successful bidder fails to procure the fuljharu at the price quoted after making the complete payment within one week time, the order will automatically stand canceled from the date of default and next highest bidder will be declared as "Successful Bidders" for the Range without further correspondence.
17. The bidders should have valid license to carry in trade to carry in trade in Forest Produces (FTL)

18. The bidders have to provide information about name, Phone number, Addhaar card of the bidder as well as of their Authorized representative in tender document itself. Successful bidder and their Authorized representatives/ agents will have to produce the document (ID/Addhaar/Pan) physically to the undersigned.
19. The successful bidder has to deposit 5% of value of value of the broom grass purchased from JFMC (Mini CCFC) to the revolving fund and 3% has to be deposited for TBB.
