NOTIFICATION

In exercise of the powers conferred by proviso to Article – 309 of the Constitution and all other powers enabling him in this behalf, the Governor, Tripura is pleased to make the following Rules to amend the "Tripura Government, Sepahijala Biological Complex/any other Complex/Institution Permanent Labourers (Recruitment & Condition of Service) Rules,1990" namely:-

Short title & Commencement:	<i>These Rules may be called the 'Tripura Government, Sepahijala Biological Complex/ any other Complex/ Institution Permanent Labourers (Recruitment & Condition of Service) Fourth Amendment Rules, 2014.'</i>
i. Amendment to Rule 4.b(a):	The existing provision viz. "more than 18 years of age and less than 35 years of age, the upper age limit being relaxable in case of a person belonging to Scheduled Castes or Scheduled Tribes or any Ex-Service man by 5 years: shall be substituted with the following: <i>"more than 18 years of age and upper age limit is 40 years, relaxable by 5 (five) years for SC/ST/PH category"</i>
ii. Amendment to sub Rule 4.(b):	In the Sub-rule 4(b), the existing provision viz. committee consisting of the DFO/WLW the establishment, DCF (P&D)/DCF (HQ) from Forest Head Quarter and concerned Conservator of Forests. In respect of Forest HQ, the committee will consist of two DCFs & a Conservator of Forests; as decided by the CCF (Administration) shall be substituted with the following: <i>Committee consisting of</i> <i>For the Offices of Divisional Forest Office & Wildlife Warden</i> <i>of Forest Department:-</i> <i>i. DFO/WLW – Chairman.</i> <i>ii. Additional DFO-Member Secretary.</i> <i>iii. Range Officer (HQ Range of Division/Sanctuary) Member.</i> <i>iv. In-Charge, Establishment Section-Member.</i> <i>v. In absence of Addl.DFO, HQ Range Officer may act as member Secretary.</i> <i>a. For Forest Head Quarter and other functional Forest Division at Agartala:-</i>
