NOTICE INVITING TENDER FOR SALE OF ARJUN FLOWER BROOMS

Sealed tenders in plain papers are hereby invited from valid Forest Trade licence holders on behalf of the **Chairman Craft & More** (Tripura Forest Environment Improvement & Poverty Alleviation Society or TFIPAS in short) for disposal of four (04) lots of Arjun Flower Brooms (Fuljharu) of 5000 nos brooms each named Lots No.1,2,3 and 4 on 'as- is- where is' basis.

2. Tenders will be received in the office of **PMU Building, Gandhigram till 3:00 P.M on 31st October '2018** and those will be opened on 31st October 2018, **at 4:00 P.M** in the office of the PMU Building, Gandhigram, in presence of participants or their authorized representatives, who may wish to remain present.

3.1 Earnest money deposit Rs.5000/- against each Lot in the form of D-Call on any scheduled Bank payable at Agartala and pledged in favour of "Chairman Crafts & More, Tripura JICA Project, Gandhigram, Agartala" shall be acceptable.

3.2 Rates, excluding tax, duty, etc, shall be quoted in tender document both in words and figures against each of broom lots as indicated against the particular lot.

3.3 Envelops containing the tender or tenders shall be super-scribed as "**TENDER FOR PURCHASE OF ARJUN FLOWER, BROOMS DATE OF OPENING "31st October' 2018"**.In the Tender/bids the bidder should mention their contact number and Address clearly along with the bids.

3.4 Tax, duty, etc. on brooms sold by Crafts & More shall be payable by the purchasers as per statute.

3.5 In case the PMU building remains closed due to any reason unforeseen or otherwise on the date and time of tender as indicated in paragraph 2 of this Notice, the intending individuals, firms and agencies may deposit their tenders on the next working day at the same time as notified for the first date with all other terms and conditions remaining unaltered.

3.6 Sealed tenders/Bids by Registered Posts/speed post shall also be accepted subject to receipt on or before the scheduled date and time as per tender notice. No tender by courier will be accepted.

3.7 Earnest endeavours shall be made for prompt release of EMD against unaccepted tenders within 15(fifteen) days from the date of finalization of process of tenders, unless otherwise advised for adjustment against payment for other successful tenders .



3.8 Written confirmation regarding acceptance of rate or otherwise of the highest valid tenders will be issued within 7(seven) days from the date of opening of tenders, and a copy of the result will also be put on the PMU notice board and uploaded immediately on the website of PMU. Due to the uniformity in quality aspect of different lots mentioned in Notice inviting Tender before dropping of Tender, Party may inspect the lots at PMU on 12.10.2018 11.00 AM to 2 PM. Prospective Bidders are advised to satisfy themselves about the Quality and quality of materials and no complaints whatsoever in this respect shall be entertained once the bid (s) have been accepted.

3.9 Full payment against allotted lot or lots shall be made by the successful tenderer by deposit including advice for adjustment of EMD and credit of the balance amount in favour of Chairman **Crafts & More** Tripura JICA Project" in the bank account of particulars of which shall be notified in the letter of acceptance of tender. The above payment or deposit has to be made within 07 (seven) days from the date of issue of communication accepting the tender or tenders, failing which the acceptance for one or more lots, depending on the payment actually made, may be cancelled at the discretion of Chairman, Crafts & More and the EMD retained against such lot or lots may be forfeited without further notice.

3.10 Delivery order against each lot will be issued separately on realization of the full payment of dues as per order of acceptance, and the buyers will be required to lift the allotted stock within 15 (fifteen) days from the date of issue of delivery order, failing which **Chairman Crafts & More** at its discretion may charge Go-down rent @ Rs.100/- (Rupees one hundred) only per 5000 nos. broom per day for delayed completion of lifting counted from the date of issue of Delivery Order, of the sold stock from the particular Go-down of CEO & PD, which the purchaser will have to pay before release of the stock. Delay in lifting of stock for more than 10(ten) days from the time allowed in the delivery order, counted from the date of issue of delivery order, shall be construed as unusual, and the Chairman Crafts & More may at his discretion cancel the sale and delivery order and forfeit up to an amount equivalent to the corresponding EMD from the deposit account of the defaulting party without further notice. Further, the sold stock shall remain in the Chairmans **Crafts & More** Go-downs, after expiry of the stipulated time as per delivery order, at the risk and cost of the buyer or buyers.

3.11 The Chairman **Crafts & More** reserves the right to accept or reject any tender/ tenders including the highest one without assigning any reason or reasons thereof, whatsoever.


3.12 All or any dispute arising out of this notice and / or the transactions and / or other action or actions resulting from this notice shall be subject to the jurisdiction of the court of law at Agartala.
