The Rule 23 ,Subjects-rates and contracts(2) Financial Ceiling limits and (3) of DFPRT-2017 is applicable to select the lowest bidders of 46 items. The Tender parties or bidders shall be selected separately for each item on the basis of the lowest rate and other valid considerations.

Eligible Tenderers shall participate in Tendering only in **online** through website <https://tripuratenders.gov.in>. Tenderers are allowed to Tender 24x7 until the time of Tender closing, with option for Re-Submission, wherein only their latest submitted Tender would be considered for evaluation. The e-Procurement website will not allow any Tenderer to attempt Tendering, after the scheduled date and time. **Submission of Tenders physically is not permitted.**

The interested tenderers shall have to submit tender papers separately in two separate sealed envelopes, **one containing technical bid and the other containing financial bid** for participation in the tendering process.

Earnest Money is to be drawn separately on any Nationalised Bank or any other scheduled Bank guaranteed by the RBI, in the shape of “**Deposit at call**”/ “**Demand Draft**” in favour of the **DISTRICT FOREST OFFICER, Sepahijala District ,Tripura**. **If any bidder not interested all items then the EMD will be 2.5% of the market of total items.**

Demand drafts furnished as above shall be valid for a minimum period of **3 (three) months** from the last date of publishing of Tender.

The Tenderers will have to upload the scan copy of the drawn “Demand Draft”/ “Deposit at call” (as a single PDF file of 100 dpi resolution), against the related Tender Earnest money, along with the Tender.

The Tenderers will also have to deposit the original “Demand Draft”/ “Deposit at call”, related to the Earnest Money as stated above, in a sealed envelope depicting DNIT No. the Tenderers Name, Address& Phone number, at the DISTRICT FOREST OFFICER, Sepahijala District, Tripura positively before the Tender opening schedule (i.e. up to **3.00 P.M** on **02/07/2019**).
