



Sealed tender on plain paper are hereby invited by the undersigned on behalf of Government of Tripura from any *bona fide* Indian Citizen for disposal of confiscated 210 (two hundred ten) seized bi-cycles under **Bagafa Forest Sub-Division, Santirbazar, South Tripura**. Sealed tender may be submitted addressing to the undersigned in sealed covered as the "Sub-Divisional Forest Officer, Bagafa, Santirbazar: South Tripura" upto 15:30 pm hrs of **30/01/2018**. The same may be opened on the same date at 16:00 hrs, if possible, subject to the below mention **terms and conditions**:

Terms & Conditions

1. The tender may be sent by **Registered/Speed Post** or **by Hand** or **may be dropped in person** in the tender box to be kept in the O/o the undersigned in sealed cover upto the time and date as quoted earlier above;
2. Any *bona fide* Indian Citizen is eligible to participate in the tender with his proof of residence, Nationality & Originality.
3. The rate of fee is to be quoted both in words and figures.
4. An EMD of Rs. 5,000/- (Rupees five thousand only) should be deposited in favour of the undersigned along with the Tender. Upon finalization, the same shall be converted as security deposit against the successful bidder.
5. Earnest money of successful tenderer except the first, second & third highest tenders will be released within fifteen days from the date of opening of tender.
6. Bi-cycle will be delivered on "**as is where is basis**" and no complaint regarding quality will be entertained. The tenderer must satisfy themselves about quality after field verification at Belonia Beat Office & Bagafa depot (lying at SDFO's Office Complex, Bagafa) on any working day during office hrs.
7. The security money will be released after lifting the 210 number Bi-cycles.
8. No dragging, lifting, storage, transportation and other facilities will be provided to the successful tenderer from the Forest Department.
9. The materials will have to be lifted by the successful bidder within 10 (ten) days of the date of depositing of Government dues, royalty, taxes, etc. in case of default the department shall not be liable to any loss / damage to the produces.
10. If the successful bidder fails to fulfill the contractual obligation, the security deposit shall be forfeited forthwith.
11. The undersigned reserves the right to accept or reject any tender including the lowest one without assigning any reason, whatsoever.
