1st CLAIMANT NOTICE

WHEREAS, It has been brought to the notice of the undersigned by Sri Tapan Saha, Forester In – Charge Forest Protection Unit (FPU), Teliamura under Sub – Divisional Forest Officer, Teliamura, the seized and Offence Report No. **08/FPU-TLM/ 2025 - 26** dated 23.06.2025 & Memo. No. **08/FPU-TLM/ 2025 – 26 / 104 - 105** dated 30.06.2025 & endorsement by the Sub-Divisional Forest Officer, Teliamura vide No. **F.10 - 2/ OR/Seized-Veh /SDFO/TSD-2025 - 26 /TR03E – 1733 / 2654 - 56** dated 23.07.2025 that on dated 13.06.2025 at about 04:30 AM, while patrolling duty along with accompanied staff over Chakmaghat area, they have got an information from the reliable source that a vehicle (Bolero Maxi Truck) loaded with sawn timber stands at Chakmaghat Sal Bagan area, then they went to the spot and noticed a vehicle was running on road, seeing that they gave signal to stop the vehicle after stopping the driver of vehicle fled away from the spot by leaving the vehicle, then they have searched over the vehicle and found loaded **Sal Sawn timber volume: 0.159m³**, which vehicle's bearing Registration No. **TR03E– 1733 Bolero Maxi Truck with Engine & Chassis No. Nil, Model: Bolero Maxi Truck, Colour: not available**, there were no valid documents, such as Hammer impression, GP-TP, Carrying license or prior permission the competent Authority, which is apparently, procured illegally.

AND WHEREAS, it has been reported by Sri Tapan Saha, Forester In – Charge Forest Protection Unit (FPU), Teliamura under Sub – Divisional Forest Officer, Teliamura being satisfied about illegally collection & transportation of said forest produce by using the vehicle he has seized the vehicle bearing Registration No: **TR03E– 1733 Bolero Maxi Truck with Engine & Chassis No. Nil, Model: Bolero Maxi Truck, Colour: not available** along with **Sal Sawn timber volume: 0.159m³** from the **Chakmaghat Salbagan area** and brought it to the Range Office Complex, Teliamura for safe custody.

WHEREAS, in exercise of the powers conferred upon by vide notification No .F7(86)/For/FP-86/14469 date, 09/06/1987 and No.F.13 (103)/For/Esst-2014/ 50233-297 dated 12/02/2015 of the Forest Department Government of Tripura as an Authorized officer for the purpose under Sub-sec.2 of Sec.52 (A) of Indian Forest (Tripura second Amendment) Act, 1986 it is contemplated to confiscate said seized vehicle bearing Registration No **TR03E– 1733 Bolero Maxi Truck with Engine & Chassis No. Nil, Model: Bolero Maxi Truck, Colour: not available** for its use in collection & transportation of forest produce of questionable origin in commission of Forest Offence U/s: 41, 42 & 52 of Indian Forest Act, 1927 and rules made there under by the Govt. of Tripura.

NOW THEREFORE, it is hereby brought to the notice of the legal owner (s) / authorized representative of the said vehicle to prefer his / her / their claim over the seized vehicle before the Authorized Office (District Forest Officer Khowai) within **30 (thirty) days** from the date of issue of this Notice along with copies of all relevant documents regarding law full ownership of the said seized vehicle. If the owner (s) or his / her / their authorized failed to prefer any claim over the seized vehicle within stipulated period, the decision regarding confiscation of the vehicle along with seized forest produces should be taken ex-parte. Till such time the vehicle along with seized produces will remain under safe custody at Teliamura Range office complex.
