AUCTION NOTICE (2nd Call)

Sealed Auctions on plain paper are hereby invited by the undersigned on behalf of the Governors of Tripura from Forest Trade License holders for disposal of departmentally operated Agar wood over 6,204.87 Kg extracted during 2024-25 under Dharmanagar Forest Sub-Division. Auction may be dropped in the box kept at SDFO's Office on all working days or may be sent through "Registered Post". The sealed Auctions should be dropped/ reached this office on or before 5.00 PM on 25/09/2025.

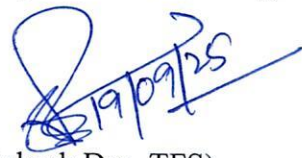
TERMS & CONDITION

1. Sealed Auctions sent by the "Registered Post"/ Auctions to be dropped must reach this office within 5.00 PM on 25/09/2025 positively. No Auction will be received after the stipulated time & date. The Auction will be opened on 26/09/2025 at 11.00 AM if not possible will be opened on next working day. Auctions or their authorized representative may remain present at the stipulated time.
2. Name of Auction must be printed/written on the top of Sealed Auction.
3. All F.T.L holder of Forest Department, Tripura are eligible to participate in the Auction and copy of valid F.T.L, Identity proof: Adhaar card, PAN Card, upto date PTC etc. & Auction copy terms and condition acceptance is duly signed by Auctioneer is to be enclosed with the Auction documents.
4. Rate per Kg of Agar Wood is Rs. 50/- as per Notification vide **NO.F.7(140)/FOR/FP-2015/10737-797, Dated- 23-06-2020 of the Joint Secretary to the Government of Tripura**. Accordingly total government value of 6,204.87 Kg Agar Wood is 3,10,243.50 (Rupees three lakh ten thousand two hundred forty three and fifty paise) only excluding of all taxes.
5. The rate must be quoted in "Per Kg basis" both in figure & in words which will exclude of GST, Income tax, surcharges on income tax & carrying / extraction cost" etc, as per rule.
6. The 'earnest money' for an amount of Rs. 5,000/- in the form of Demand Draft from any Nationalized Bank of India is to be deposited in favour of the Sub-Divisional Forest Officer, Dharmanagar. Without such earnest money, no Auction will be considered as valid and therefore out rightly will be rejected. Earnest money of successful Auction except the first, second and third highest Auctions will be released within fifteen days from the date of opening of Auction. The earnest money will be liable for forfeiture for violation of the terms and conditions laid in this Auction notice.



7. The timber will be sold & delivered on '**as is where is basis**' and no complaint regarding quantity, species and measurement etc. against any will be entertained. The Auctioneer must himself be satisfied about quantity, quality, species and measurement after verification in Jalebassa Beat before dropping the Auction. A copy of the complete list of timber and its measurement can be seen in the office of the undersigned or at Jalebassa Beat on any working day between 10.00 AM and 5.00 PM.
8. The successful Auctioneer shall have to furnish security money to the extent of 10% of the Auction and accepted value within 7 (seven) days of issuance of acceptance letter and security money will be released after disposal of timber allowed to the Auctioneer. The security money is liable for forfeiture for violation of 'term & condition' laid in the Auction.
9. The successful Auctioneer shall have to deposit the entire value of Agar wood along with GST, Income tax, Surcharges on Income taxes and carrying cost as leviable as per rule through 'GP' within 15(fifteen) days of approval of Auction by the competent authority and then transit passes for the stacks will be considered.
10. No dragging, lifting and storage etc. facilities will be provided to the successful Auctioneer and such works are to be arranged by the Auctioneer himself / herself.
11. Agar wood will have to be lifted by the successful bidder within 10(ten) days of the date of depositing of government revenue & other taxes etc. in case of default the department shall not be liable to any loss/damage to the produce.
12. The undersigned reserves the right to accept or reject any Auction including "highest one" without assigning any reason.
