The EOI will be received up to **3:00 PM on 28th August, 2025** at the registered office of TRPC Ltd., and will be opened on the same day at **3:30 PM**, if possible.

Area of Work:

The work of preparation of the DPR shall be in accordance with the latest guidelines and norms under the scheme of Micro and Small Enterprises Cluster Development Programme (MSE-CDP) of the **Ministry of Micro, Small and Medium Enterprises (MSME), Government of India**, and will primarily focus on the following areas:

- Brief particulars of the proposal
- Introduction: brief about general scenario of industrial growth/ cluster development in the state. Assessment of existing rubber production, availability, and potential for value addition in Tripura.
- Identification of cluster and its products, future prospects of products, competition scenario, backward and forward linkage etc.
- Information about SPV-registration, formation and objective etc.
- Details about Project promoters and sponsor
- Implementation of arrangement includes name, role, period, commitment of state Govt. contribution etc.
- Market analysis and demand forecasting for the proposed rubber-based products at regional and national levels.
- Preparation of a comprehensive project feasibility report including technical, financial, and environmental viability.
- Layout planning, plant & machinery selection, infrastructure requirements, and operational workflow design.
- Cost estimation and financial planning including capital investment, working capital, and revenue projections.
- Identification of key stakeholders, potential partners, and institutional support mechanisms.
- Suggestions for capacity building, skill development, and sustainability measures.
- Project component, fund requirement /availability analysis, usage charges etc.
- Comment on commercial, financial, economic viability etc.


