**CONFISCATION ORDER**

**COMPLAINANT/ PETITIONER:** Sri Basu Debbarma, Fr., A/O, FPU Pecharthal vide Offence Report No.02/FPU/PTL-2023-24 dated, 27/04/2023 and his office letter No.F.3/FPU/PTL-2023-24/161-62 dated, 22/08/2023 that on 17/04/2023 at about 1:00 AM a vehicle was detained/seized bearing registration No.TR-05B-1518, Chassis No.MA1ZT2GLKH2B5889 Engine No.GLHAB83733 (**Bolero Maxi Truck**) from Ghatacherra area, Pecharthal with loaded over 2.449 cum teak sawn timber for being used in commission of forest offence under section 41, 42, 51(A), 52 & 69 of IFA, 1927 and rules made there under by the Government of Tripura.

**CASE SUMMERY**

**WHEREAS,** It has been brought to the notice of the undersigned by Sri Basu Debbarma, Fr., A/O, FPU Pecharthal vide Offence Report No.02/FPU/PTL-2023-24 dated, 27/04/2023 and his office letter No.F.3/FPU/PTL-2023-24/161-62 dated, 22/08/2023 that on 17/04/2023 at about 1:00 AM during the time of patrolling duty with staff, he has apprehended 01 (one) no. vehicle bearing registration No.TR-05B-1518, Chassis No.MA1ZT2GLKH2B5889 Engine No.GLHAB83733 (**Bolero Maxi Truck**) from Ghatacherra area, Pecharthal with loaded over 2.449 cum teak sawn timber without permission of the authority, which apparently procured illegally.

**AND WHEREAS,** It has been reported by Sri Basu Debbarma, Fr., A/O, FPU Pecharthal has checked and seized the said vehicle registration No. No.TR-05B-1518, Chassis No.MA1ZT2GLKH2B5889 Engine No.GLHAB83733 (**Bolero Maxi Truck**) from Ghatacherra area, Pecharthal and brought to the FPU, Pecharthal Office Complex, Pecharthal for safe custody.

**WHEREAS,** in exercise of the powers conferred upon me vide Notification No.F.7(89)/For/FP-86/14469 dated, 09.06.1987 of the Forest Department, Govt. of Tripura and No.F.7(310)/For/FP-2016/25701-747 dated, 15.11.2016 of the Additional Secretary to the Government of Tripura as Authorized Officer for the purpose under Sub-Section-2 of Section-52(A) of the Indian Forest (Tripura Second Amendment) Act, 1986 it is contemplated to confiscate the said seized vehicle No.TR-05B-1518, Chassis No.MA1ZT2GLKH2B5889 Engine No.GLHAB83733 (**Bolero Maxi Truck**) from Ghatacherra area, Pecharthal for its use in carrying of forest produces of questionable origin in commission of Forest Offence of Indian Forest Act, 1927 for its use in commission of Forest Offence under section 41, 42, 51(A), 52 & 69 of IFA, 1927 and rules made there under by the Government of Tripura.

**AND WHEREAS,** it was brought to the legal owner's of seized vehicle respectively, 04 (four) times Claimant Notice vide No.F.10-6/TR05B-1518/Dt.FO(U)/2022-23/6599-640 dated, 26/09/2023 & Even No.7611-45 dated, 21/11/2023, No.11351-383 dated, 12/03/2024 & No.F.10-2/OR/Seized Veh/SDFO/KGT/TR-05B-1518/10209-252 dated, 21/12/2024 to prefer his/her/their claim over the detained/ seized vehicle before the Authorized Officer (SDFO, Kumarghat) within 30 (thirty) days from the date of issuance of these Claimant Notices along with copies of all relevant documents regarding lawful ownership(s) of the said seized vehicle.

**AND WHEREAS,** the owner's of his/her/ their authorized representatives failed to prefer any claim over the seized vehicle within stipulated period, now therefore the decision regarding confiscation of said seized vehicle alongwith seized forest produces is hereby taken ex-parte. The said vehicle alongwith seized produces is hereby confiscated to the Government of Tripura in exercise of the conferred upon me by the provision of section 55(1)(2), 56 & 57 of IFA being the authorized officer vide notification No.F.7(310)/For/FP-2016/25701-747 dated, 15/11/2016 of Addl. Secretary, Government of Tripura.

The Range Officer, Pecharthal is directed to dispose the seized forest produces as per rules.
