NOTIFICATION

WHEREAS the period under section 6 for preferring claims has elapsed and all claims, if any, made under that section or section 9 have been disposed of by the Forest Settlement Officer;

AND WHEREAS the period limited by section 17 for appealing from the orders passed on such claims has elapsed, and all appeals (if any) presented within such period have been disposed of by the appellate officer or court:

AND WHEREAS all lands (if any) to be included in the proposed forest, which the Forest Settlement Officer has, under Section 11, elected to acquire under the land Acquisition Act, 1894, have become vested in the Government under Section 16 of the Act;

NOW. THEREFORE, in exercise of the powers conferred by the Section 20 of the Indian Forest Act, 1927 (Act XVI of 1927) as amended, read with the Government of India in the Late Ministry of States Notification No. 104-J, dated the 24th August, 1950, and in supersession of the previous Notification No. F. 13 (30)-For/61 dated 2nd March, 1961 as published in the Tripura Gazette, Extraordinary issue dated 15th March, 1961 A. D., the Lieutenant Governor, hereby declares the land comprising an area of 0.238 Sq. Kilometres (0.092 Sq miles) situated within Sadar Sub-Division, Tripura, more particularly described in the schedule below, to be a Reserved Forest.

This declaration shall take effect from 1st June, 1970, and such Firest shall be deemed to be a Reserved Forest to be called "HATIPARA RESERVED FOREST".
