NOTIFICATION

It is hereby declared that the Chief Commissioner of Tripura, in exercise of the powers conferred on him by section 4 of the Indian Forest Act, 1927 (Act. XVI of 1927) read with the Government of India in the Late Ministry of States notification No. 104-J, dated the 24th August, 1950 as amended, has been pleased to decide to constitute the forest land comprising an area of 45 sq. miles approx.) situated within the Sabroom Sub-Division and Belonia Sub-Division and described by the boundary limits as specified below, as Reserved Forest to be called "KALAPANIA RESERVED FOREST" and to appoint Shri N. N. Choudhry, Additional District Magistrate & Collector, Tripura as Forest Settlement Officer, for the purpose.

SOUTH:—Starting from a point at Manugang near Jibanchandrabari and leaving cultivated lands as far as practicable on the left follows downstream of Manugang upto Manubankul. Then along an artificial line leaving Manugang and cuitivated lands as far as practicable on the left meets Manugang above Dakshin Bankul. Then follows downstream of Manugang upto the junction of Chalitachara. Then an artificial line along the upstream of Chalitachara keeping cultivated lands as far as practicable on the left. The artificial line then crosses Chalitachara at a point about 2 miles and

2 furlongs from the junction of Chalitachara and Manugang. artificial line then proceeds above Chalita Bankul to meet Manugang keeping cultivated lands as far as practicable on the left. The line then moves along the down-stream of Manugang for about a mile and then leaves Manugang and proceeds along an artificial line towards the south-west along Jharjhariabari, Begunchara keeping cultivated lands as far as practicable on the left. The actificial line then proceed, south west keeping cultivated lands as far as practicable the left meets Kalapania chera. The then moves upstream of Kalapaniya chara. for about a mile keeping cultivated lands as far as practicable on the left. The line then crosses Kalapaniya chara and keeping cultivated lands on the left meets the Sabroom Udaipur Road near Satchand Colony.

WEST:—The line proceeds north along the Sabroom-Udaipur Road upto the 34m. 5 Furlong mile-post above Mahendrabari (15 mile from Sabroom). The line then leaves the road, turns left and keeping the cultivated lands as far as practicable on the left proceeds west along a foot-path to Mohan Chandrabari. From Mohanchandrabari along an artificial line directly west till it meets the eastern foot hills of Tekka Tulshi Range. The line then proceeds north along the foot-hills a portion of the eastern boundary of Tekka Tulsi Range). The line then proceeds along downstream of Tuigamanichara keeping the cultivated lands as far as practicable on the left upto Barkholabari.

NORTH:—The artificial line then proceeds directly towards east and then towards south and then towards east and then towards north upto Hichhachara keeping cultivated lands as far as practicable on the left. The artificial line then proceeds via Udrasaibari and crosses Abhoya chara near about Oghabari to meet the Udaipur-Sabroom Road at the 29 mile 1 Furlong mile post. The line after crossing the U.S. Road proceeds towards east along Pilakchara upto its source via Kaniyacharanbari and Bhagya Charanbari.

EAST:—The line then proceeds south following the ridges of small hill ranges on the west of Kaiphang chara and Manugang to meet the starting point at Manugang near Jiban chandrabari.
