NOTIFICATION

In exercise of the powers conferred by section 29 of the Indian Forest Act, 1927, (Act XVI of 1927) read with Government of India in the late Ministry of states Notification No. 104-J, dated the 24th August, 1950 as amended, the Administrator of Tripura has been pleased to declare the forest land comprising an area of about 33 sq. miles situate within Khowai Sub-Division and described by the boundary limits as specified below, a Reserved Forest to be called ‘Khowai Catchment Reserved Forests’ with effect from 10. 11. 64.

- North :— Starting from the Junction of Khowai River and Guli Chara the boundary line proceeds up stream along Khowai river.
- East :— Proceeding along up stream of Khowai river meets Juri Chara and then proceeding a short distance along up stream of Jurichara meets Pomachara. The line then proceeding along up stream of Pomachara meets the Common boundary line of Khowai and Amarapur Sub-Division at its source.
- South :— Proceeds along the common boundary line of Khowai and Kamalpur Sub-Division till it meets the source of Gulichara (main tributary and extreme west).
- West :— The line then proceeds, along downstream of Gulichara and following adjacent to Banirapara, Godanpara and Joychandrapara continues proceeding along downstream of Gulichara till it meets the starting point at the Junction of Gulichara and Khowai river.
