## NOTIFICATION

WHEREAS the period under section 6 for preferring claims has elapsed and all claims, if any, made under that section or section 9 have been disposed of by the Forest Settlement Officer ;

AND WHEREAS the period limited by section 17 for appealing from the orders passed on such claims has elapsed, and all appeals ( if any ) presented within such period have been disposed of by the appellate officer or Court ;

AND WHEREAS all lands ( if any ) to be included in the proposed forest, which the Forest Settlement Officer, has under Section 11, elected to acquire under the Land Acquisition Act, 1894, have become vested in the Government under section 16 of the Act ;

NOW, THEREFORE, in exercise of the powers conferred by the Section 20 of the Indian Forest Act, 1927 (ACT XVI of 1927) as amended, read with the Government of India in the Late Ministry of States Notification No. 104-J, dated the 24th August, 1950, and in supersession of the previous Notification No. F. 18-4/For-66/161 dated the 11th March, 1966 and corrigendum No. F. 18-4/44/For-66/450 dated the 4th April, 1966 as published in the Tripura Gazette, dated 19th March, 1966 A. D. and 9th April, 1966 A. D. respectively, the Lieutenant Governor, hereby declares the land comprising an area 2.875 Sq. Kilometres (1.11 Sq. miles) situated within Sadar Sub-Division, West Tripura, more particularly described in the Schedule below, to be a Reserved Forest.

This declaration shall take effect from 1.2.72 and such Forest shall be deemed to be a Reserved Forest to be called "PATHALIA FUEL RESERVED FOREST".

AND WHEREAS the period limited by section 17 for appealing from the orders passed on such claims has elapsed, and all appeals (if any) presented within such period have been disposed of by the appellate officer or Court ;

AND WHEREAS all lands (if any) to be included in the proposed forest, which the forest settlement officer, has under section 11, elected to acquire under the Land Acquisition Act, 1894, have become vested in the Government under section 16 of the Act ;

NOW THEREFORE, in exercise of the powers conferred by the section 20 of the Indian Forest Act, 1927, (Act XVI of 1927) as amended read with the Government of India in the Late Ministry of States Notification No. 104-J, dated the 24th August, 1950, and in supersession of the previous Notification No. F.2087/DC/65 dated the 31st August, 1965 as published in the Tripura Gazette, dated the 4th September, 1965 A. D., the Lieutenant Governor, hereby declares the land comprising an area 27.531 sq. kilometres (10.63 sq. miles) situated within Sadar and Khowai Sub-division, District-West Tripura, more particularly described in the schedule below, to be a Reserved Forest.

This declaration shall take effect from 1.2.72 and such Forest shall be deemed to be a Reserved Forest to be called "CHAMPAMURA RESERVED FOREST".
