D., the Government of Tripura, hereby declares the land comprising an area of 24-42 Sq. kilometres (9-43 Sq. miles) situated within Sadar Sub-Division, West Tripura District, more particularly described in the schedule below, to be a RESERVED FOREST.

This declaration shall take effect from 1st January, 1976 and such Forest shall be demand to be a RESERVED FOREST to be called PATHALIA RESERVED FOREST'.
