It is hereby declared that the Governor of Tripura in exercise of the powers conferred on him by section 4 of the Indian Forest Act, 1927 read with the Govt. of India in the late Ministry of States Notification No. 104-J dated the 24th August, 1950 as amended has been pleased to decide to constitute the erstwhile protected Forest land comprising an area of 1.680 sq. K. M. situated within Udaipur Sub-Division and more specifically described by the schedule of lands as appended herewith into a Reserved forest to be called " R. K. PUR EXTENSION

RESERVED FOREST " and to appoint Assistant survey Officer. Udaipur, of the Directorate of Settlement & Land Records as a Forest Settlement Officer for the purpose.
