M. situated within Amarpur Sub-Division more specifically described by the schedule of land as appended herewith into a Reserved Forest to be Called "RANGKANG RESERVED FOREST" and to appoint Assistant Survey Officer, Udaipur of the Directorate of Settlement & Land Records as a Forest Settlement Officer for the purpose.
