## NOTIFICATION

WHEREAS the period under section 6 for preferring claims has elapsed, and all claims, if any, made under that section or section 9 have been disposed of by the Forest Settlement Officer ;

AND WHEREAS the period limited by section 17 for appealing from the orders passed on such claims has elapsed, and all appeals (if any) presented within such period have been disposed of by the appellate officer or court ;

AND WHEREAS all lands (if any) to be included in the proposed forest, which the Forest Settlement Officer has, under section 11, elected to acquire under the Land Acquisition Act, 1894, have become vested in the Government under section 16 of the Act ;

NOW, THEREFORE, in exercise of the powers conferred by section 20 of the Indian Forest Act, 1927 ( Act XVI of 1927 ) as amended, read with the Government of India in the Late Ministry of States Notification No. 104-J, dated the 24th August, 1950, and in supercession of the previous Notification No. F 13(42)/For-61 dated 22. 4. 61 as published in the Tripura Gazette Extraordinary issue dated 25th August, 1961 A. D. the Chief Commissioner hereby declares the land comprising an area more or less 9.29 Sq. Kilometres (3.58 Sq. miles) situated within Kailashahar Sub-Division, Tripura more particularly described in the schedule below, to be a Reserved Forest

This declaration shall take effect from the 1st October, 1968, and such forest shall be deemed to be a Reserved Forest to be called "SAMRU-HALAI RESERVED FOREST"
