1st SHOW CAUSE NOTICE

WHEREAS, It has been brought to the notice of the undersigned by Sri Tapan Saha, Forester In – Charge Forest Protection Unit (FPU), Teliamura under Sub – Divisional Forest Officer, Teliamura, the seized and Offence Report No. 06/FPU-TLM / 2025 - 26 dated 15.06.2025 & Memo. No. 08/FPU-TLM/2025 - 26/ 87 - 88 dated 15.06.2025 & endorsement by the Sub-Divisional Forest Officer Teliamura vide No. F. 10 - 2/ OR/Seized – Veh / SDFO/TSD-2025 – 26 / TR01AW – 1614 / 1420 - 22 dated 19.06.2025 that on dated 24.03.2025 at about at about 03: 00 PM while performing duty along with accompanied staff of Forest Protection Unit (FPU), Teliamura over **Jhum bari area**, at about 06: 00 PM an information was received from the Mungiakami Police Station about detention of a vehicle (Bolero Maxx PUB) then they went to Mungiakami Police Station after completion of all formalities the in – charge of Mungiakami Police Station hand over the vehicle along with loaded **Karui Sawn timber volume: : 2. 183 m3** to in – charge FPU. Teliamura which Registration. No: TR01AW – 1614 Mahindra Bolero Maxx PUP Engine No. TTP1E24064 Chassis No: MA1RA2TTKP1E48291, Model: Mahindra Bolero Maxx PUB HD 1.7LX (LGV) Colour: White, there were no GP –TP, Hammer impression and no carrying license of vehicle or prior permission from the competent Authority., which is apparently procured illegally.

AND WHEREAS, it has been reported by Sri Tapan Saha, Forester In – Charge Forest Protection Unit (FPU), Teliamura under Sub – Divisional Forest Officer, Teliamura has re-seized the vehicle bearing Registration No TR01AW – 1614 Mahindra Bolero Maxx PUB Engine No. TTP1E24064 Chassis No: MA1RA2TTKP1E48291, Model: Mahindra Bolero Maxx PUB HD 1.7LX (LGV) Colour: White from the custody of Mungiakami Police Station for engaging in collection and transportation of Karui Sawn timber volume: 2. 183 m3 and brought it to the Range Office complex Teliamura for safe custody.

WHEREAS, in exercise of the powers conferred upon me vide Notification No.7 (86)/ For/FP-86/14469 dated, 09/06/1987 and No.F.13 (103)/For/Esst-2014/ 50233 dated 12/02/2015 of the Forest Department Govt. of Tripura as an Authorized officer for the purpose under Sub-Sec.2 of Sec.52 (A) of Indian Forest (Tripura Amendment) Act, 1986 it is contemplated to confiscate the said seized vehicle bearing Registration No: TR01AW – 1614 Mahindra Bolero Maxx PUP, Engine No. TTP1E24064 Chassis No: MA1RA2TTKP1E48291, Model: Mahindra Bolero Maxx PUB HD 1.7LX (LGV) Colour: White from the Police custody of Mungiakami Police Station for its use in carrying of Forest products of questionable origin in commission of Forest Offence of Indian Forest Act, 1927. In commission of Forest Offence under Section 41, 42 & 52 of IFA 19. and rules made there under by Government of Tripura.

AND WHEREAS, Sri Buddha Debbarma (legal owner), S/o Sri Manindra Debbarma of village Bir Chandra Para, Subal Singh, Post Office: Subal Singh, Police Station: Sidhai Mohanpur, Sub – Division: Mohanpur, District: West Tripura has preferred his authorized ownership and claimed over the vehicle bearing Registration No TR01AW – 1614 Mahindra Bolero Maxx PUB Engine No. TTP1E24064 Chassis No: MA1RA2TTKP1E48291, Model: Mahindra Bolero Maxx PUB HD 1.7LX (LGV) Colour: White by submitting documents against said seized vehicle in support of his claim.

Khowai) on any working days within 15 (Fifteen) days from the date of issue of this notice **1] Source of Timber & destination 2] Is any valid GP / TP taken from the competent Authority for carrying of Timber 3] Vehicle used for carrying with having carrying license or not ? Why does not the vehicle to be confiscated to the Government of Tripura for using in illegally carrying of forest produces by using this vehicle, your clarification should be submitted within stipulated days, failing which decision regarding confiscation of vehicle bearing Registration No TR01AW – 1614 Mahindra Bolero Maxx PUP Engine No. TTP1E24064 Chassis No: MA1RA2TTKP1E48291, Model: Mahindra Bolero Maxx PUB HD 1.7LX (LGV) Colour: White will be taken expert.**
