AND WHEREAS all lands (if any) to be included in the proposed forest, which the Forest Settlement Officer has, under section 11, elected to acquire under the Land Acquisition Act, 1894, have become vested in the Government under section 16 of that Act;

NOW, THEREFORE, in exercise of the powers conferred by section 20 of the Indian Forest Act, 1927 (Act XVI of 1927) as amended, read with the Government of India in the Late Ministry of States Notification No. 104-J, dated the 24th August, 1950, and in supersession of the previous Notification No. F. 2126/DC/65, dated the 4th September, 1965 as published in the Tripura Gazette, Part I, September, 18, 1965 A. D. the area Commissioner hereby declares the land comprising an area more or less 8.21 Sq. Kilometres (3.17 sq. miles) situated within Kailashahar Sub-Division, Tripura more particularly described in the Schedule below, to be a reserved forest.
