1. The quotation should be addressed to the Director, NTFP Centre of Excellence, Hatipara, Gandhigram clearly mentioning the quotation reference number.
2. The bidder should submit govt. registration certificate/trade license along with the quotation.
3. The bidder should submit copy of GST registration along with copy of updated valid tax clearance certificate (i.e., ITC/PTC) with registration.
4. The bidder should not be black listed by the Government of Tripura or by any Central agency. A declaration in this regard is required to be submitted by the bidder.
5. The quotation should be dropped only in the NCE Tender Box kept at NCE office at Hatipara, Gandhigram, Agartala.
6. Rate should be quoted both in words and figures.
7. Payment will be made on completion of the delivery/ completion of the work against bill to be submitted in triplicate.
8. Rates should be quoted mentioning GST %.
9. The accepted rates shall remain valid for a period of 1 (one) year from the date of acceptance of rate.

10. The quantity of requirement may be increased or decreased.
11. Taxes will be deducted from the final bill as per Government rules.
