2nd CLAIMANT NOTICE

WHEREAS, it has been brought to the notice of the undersigned by Sri Sibu Das, FR, RO, Bishalgarh, Vide his OR No. 05/RO-BLG/24-25/OR Dated, 01/07/2024 and Memo No.F.50/RO-BLG/24-25/OR/157, Dated, 03/07/2024, that vehicle bearing Registration No.TR01-T-1886 (Bolero Maxi Truck) was seized while performing patrolling duty by FR, RO-Bishalgarh along with staff has intercepted 01 (one) no. Vehicle bearing Registration No.TR01-T-1886(Bolero Maxi Truck) illegally Collection Sawn Timber over 0.619 cum without document on 01/07/2024 at about 02.00 AM, at No.2 Chandranagar, PWD road under Bishalgarh Range of questionable origin.

AND

WHEREAS, Shri Sibu Das, FR, RO-Bishalgarh along with his staffs checked the said vehicle and found no Valid documents etc for illegal collection and carrying 0.619 cum Sawn Timber. The said vehicle bearing Registration No.TR01-T-1886 (Bolero Maxi Truck) was then seized and brought to the Bishalgarh Range Office Complex.

AND

WHEREAS, in exercise of the powers conferred upon me vide Notification No.F.7 (86)/For-FP-86/14469 dt. 09/06/1987 and No.F.13 (103)/For/Estt/2014/50233 dated 12/02/2015 of the Forest Department Government of Tripura as Authorized Officer for the purpose under Sub-Sec 2 of Sec 52 (A) of Indian Forest Act, (Tripura Second Amendment) Act, 1986, it is contemplated to confiscate the said vehicle bearing registration No.TR01-T-1886 (Bolero Maxi Truck) for illegal collection and carrying 0.619 cum sawn timber of Forest produce of questionable origin in commission of Forest offence under section 52 (2) (A), 41 (2) (B) & 42 of Indian Forest Act, 1927 and rules made there under.

AND

NOW THEREFORE, it is hereby brought to the notice of the authorized owner legal owner (s) of the said seized vehicle bearing Registration No. TR01-T-1886 to prefer his/her/their claim over the said vehicle to the Authorized Officer (Sub-Divisional Forest Officer, Bishalgarh within **30(thirty)** days from the date of issue of this notice along with copies of all relevant documents regarding lawful ownership of the said vehicle. If the owner(s) or his/her/their representatives fail to prefer any claim over the seized vehicle within stipulated period to the undersigned, the decision regarding the confiscation of the seized vehicle No.TR01-T-1886 (Bolero Maxi Truck) shall be taken ex-parte. Till such time the vehicle along with seized produced will remain under the custody of Bishalgarh Range.

2nd CLAIMANT NOTICE

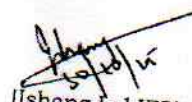
WHEREAS, it has been brought to the notice of the undersigned by I/C FPU-Jampuijala, Vide his OR No. 55/FPU-JMPJ/24-25/OR Dated, 02/11/2024 and Memo No.F.4/ FPU-JMPJ /24-25/OR/520-22, Dated, 02/11/2024, that vehicle bearing Registration No.TR01-N-1514 was seized while performing patrolling duty by I/C FPU-JMPJ along with staff has intercepted 01 (one) no. Vehicle bearing Registration No.TR01-N-1514 illegally Collection Round timber (Lamun Log) over 1.683 cum without document on 02/11/2024 at about 11.30 AM, at Gokulnagar, Raastermatha Near TSR Camp under Bishalgarh Range of questionable origin.

WHEREAS, I/C FPU-JMPJ along with his staffs checked the said vehicle and found no Valid documents etc for illegal collection and carrying 1.683 cum round timber (Jamun Log). The said vehicle bearing Registration No.TR01-N-1514 was then seized and brought to the 1st Gate of Wildlife Centaury, Sepahijala Complex and kept in safe custody.
