**NOTICE INVITING EXPRESSION OF INTEREST (EOI) FOR THE PURPOSE OF BROOM GRASS (FULJHARU/ARJUN FLOWER) FOR THE COLLECTION SEASON 2018-19**

- The undersigned invites Expression of Interest (Eoi) from interested buyers of dry old (2015-16) broom grass stored in Mini CCFC at Mohankanta JFMC under Nityabazar Beat of RMU, Killa with the terms & conditions as mentioned below, along with earnest money (EMD) to be deposited with the bids.
- The Eoi should reach to this Office of the undersigned by registered post or dropped in the Eoi box by hand positively within the Office hour of 30.11.2018 up to 3:00 PM. The Eoi shall be opened in the office chamber of the undersigned on the same date if possible at 3:30 PM while the traders/bidders may remain present.

Approx-3200 KG


**TERMS AND CONDITION**

1. D. Call for an amount of Rs. 5000.00 (Rupees five thousand) only placed in favour of the (Sub Divisional Forest Officer, Udaipur Forest Sub Division) has to be enclosed along with the Eoi without which no offer will be treated valid for acceptance. In case of successful traders/bidders, the earnest money will be forfeited in case of non compliance of terms and condition of the Eoi.
2. The Broom garss will be sold on as is where basis. Interested bidders may physically verify the stock lying at Mini CCF of Mohankanta JFMC under Nityabazar Beat of Killa RMU for satisfaction.
3. The traders/bidders have to quote rates per KG for dry & old broom grass in the following format.

SN	Item	Rate quoted
1	Old dry broom garss	Rs. Xxxx / KG excluding royalty and other applicable taxes and RF deposit


4. The bidder who has quoted highest price will be declared successful to purchase of the dry & old broom grass at the price quoted.
5. No person other than the successful bidder or his Authorized representative shall be allowed to procure the fuljharu from the concerned Range. Forest Department will issue transit pass for fuljharu only to the Authorized representative of the successful bidder, on realization of the royalties, RF contribution and other dues of the Government. The successful bidders shall procure broom grass (Dry & Old) from the mini CCFC of Mohankanta JFMC under Nityabazar Beat of Killa RMU.
6. In case, the successful bidder fails to procure the fuljharu at the price quoted after making the complete payment within one week time, the offer will automatically stand canceled from the date of default and next highest bidder will be declared as "Successful Bidder" for the Range without further correspondence.

7. The bidders should have valid license to carry in trade in Forest Produces (FTL).
8. The base price of the dry & old broom grass is Rs. 50/- (Rupees fifty) only.
9. Prospective bidders should quote over and above the base prize.
10. The bidders have to provide information about name, phone number, Addhaar Card of the bidder as well as of their Authorized representative in tender document itself. Successful bidder and their Authorized representatives/ agents will have to produce the document (ID/Addhaar/PAN) physically to the undersigned.
11. The successful bidder has to deposit 5% of value of the broom grass purchased from JFMC (Mini CCFC) to the revolving fund.
12. Other information may be known from the office of the undersigned.
